While, sadly, this year already has seen terror attacks in France, we know that it will be a very significant year for the UEMS, when we move into our new home, Domus Medica Europaea (DME).

The UEMS Executive met on Saturday to review progress on DME and to prepare for the year ahead.

We are pleased to report, following our inspection of the building works, that:

- the refurbishment of DME very likely will be completed before the end of January;
- the UEMS Secretariat will move into DME in mid-February;
- **The official opening ceremony of DME will be on 10<sup>th</sup> April 2015**, at the time of the Council meeting in Brussels.

While the official invitations will be sent out soon, we are writing to you now to encourage you to "save the date" for this important milestone in the history of the UEMS and in the representation of all doctors in Europe.

The UEMS already has received applications from European, National and Speciality organisations who are interested in being based in DME, with site-visits arranged and tenancy agreements being prepared.

**We strongly encourage you to apply now if your organisation wants an office in DME.**

While preference will be given to the UEMS family, this cannot be guaranteed indefinitely.

**We also encourage you to book DME for your meetings and European Examinations.**

A fee will be applied, to contribute to the purchase and running costs of DME.
